As per the resolution adopted at the State Environment and Forest Ministers' Conference in New Delhi on 6<sup>th</sup> and 7<sup>th</sup> April, 2015, it has been decided that States will prepare demonstration projects under Climate Change Action Programme (CCAP) during Financial Year 2015-16. The MoEF&CC has notified UNDP to assist the state of Jharkhand for preparation of projects for submission to Green Climate Fund and other funding agencies.


Accordingly International Institute for Energy Conservation (IIEC), an agency of UNDP has prepared two projects on Adaptation and Mitigation.

The presentation of the projects made by IIEC during CSG meeting held on 9<sup>th</sup> October, 2015, a committee is being constituted to examine, scrutinize, give suggestions and feedback on the proposals submitted by IIEC.
